

Notes of Application for International Students in 2022

I. Application

• **Maximum Number of enrollment students: 6**

Eligibility for Application

- Examinees of foreign nationalities must be at least 18 years old and hold the graduation certificate (graduating students may submit an official document indicating their status as enrolled graduating students) from Senior High School and the transcripts.
- Examinees of foreign nationalities must hold a certificate for Level 3 or above of Chinese Proficiency Test (HSK) with the result no less than 180 points (Certificate should be submitted before April 1, 2022), No-criminal record, Financial status certificate and Health examination certificate issued within the recent 3 months.
- According to the regulations specified in Notice of the Ministry of Education on standardizing the acceptance of international students in Chinese universities, the following regulations are made for international students who apply for undergraduate study in Central Conservatory of Music:

i. According to Chapter 5 of the Nationality Law of the People's Republic of China, if both or one of the parents are Chinese citizens and settled in a foreign country, the person who holds foreign citizenship at birth cannot hold Chinese citizenship. Since 2021, the applicants that act as international students to start the undergraduate program of colleges and universities must have held valid foreign passports or documents indicating their nationalities for at least 4 years or above in addition to the college's other qualified registration requirements. Besides, they must have records of having settled abroad for over 2 years in the recent 4 years by the end of April 30 in the enrollment year. (The

living up to 9 months abroad in one year can be counted as one year based on the dates indicated by the entry stamp or exit stamp on the passport.)

ii. Residents of the mainland, Hong Kong, Macau and Taiwan who apply for the undergraduate program of colleges and universities serve as international students after immigration and held foreign citizenship. Meanwhile, they should also qualify the first requirement above.

The applicants should provide the following certifications based on the requirements above:

1. The applicants who were Chinese citizens originally and joined the foreign nationality later should provide:

- 1) Cancellation certificate of China nationality and registered residence;
- 2) Certificate of jointing the foreign countries;
- 3) Exit and entry stamps on passport from April 30, 2018 to April 30, 2022.

2. The applicants who hold foreign citizenship at birth and both or one of parents is Chinese citizen should provide:

- 1) The certificate of the applicant holding foreign nationality at birth;
- 2) The permanent resident certificate in foreign countries of the applicant's Chinese parent before the applicant's birth;
- 3) Exit and entry stamps on passport from April 30, 2018 to April 30, 2022.

Means of Application

Only online application is acceptable for admission in the conservatory. Applicants may either refer to the admissions website of the conservatory: <http://zhaoban.com.edu.cn> , or enter the "Undergraduate Enrollment System" via the link "Admission" on the homepage of the official website: <http://www.ccom.edu.cn> .

Application time

Start from 9:00am, Jan 4, 2022

End at 12:00am, Jan 11, 2022

Opening time of the system during Jan 4 to Jan 10: 09:00-21:00

Opening time of the system on Jan 11: 9:00-12:00am

Applicants must complete all the registration procedures within the prescribed registration time. Overdue registration will not be accepted. The time for printing the admission ticket online and the examination schedule will be notified separately. Special Notices

- We do not accept the application by post or on-site. All applicants must apply online.
- The examination fees paid by applicants will not be refunded whether they are enrolled or not (including abandoning exams and being absent from exams).
- Applicants must show the original ID and admission ticket during attending the examination.
- If the applicant's repertoire does not match the repertoire in the submitted application form, the test score will be less than 50 points. Audition repertoire cannot be changed once submitted online.

II. Method of Application

- i. Applicants applying for study in the conservatory with national scholarship or other public financial support shall apply to the relevant departments through diplomatic channels in the home countries in person.
- ii. The self-financed international students can apply directly to the International Students' Office at Central Conservatory of Music. Applicants may first download the "Application Form for International Students at Central Conservatory of Music" from <http://liuxue.ccom.edu.cn> and send it by email via pchunni@ccom.edu.cn. Other

After the information confirmed by the conservatory, the applicants should provide the following documents:

- 1) Passport or document indicating the nationality;
- 2) Notarized graduation certificate from Senior High School (graduating students may submit an official document indicating their status as enrolled graduating students) and transcript (a copy is acceptable).
- 3) A certificate for Level 3 or above of Chinese Proficiency Test (HSK) (the score should be equal or more than 180 points)
- 4) No-criminal record certificate
- 5) Document to certify the applicant's financial situation
- 6) Health certificate (issued within the recent 3 months)
- 7) Other documents mentioned in ***Eligibility for Application***

III. Professional Examination

Online Examination ONLY.

The applicants to the Voice & Opera Department should submit the prescreening video in the first round, and the operation method will be notified separately.

The examination time of Composition Department, Conducting Department, Musicology Department, Music Education Department, Piano Department, Orchestral Instruments Department, Traditional Chinese Instruments Department, Violin Making and Research Center, Music AI and Information Technology Department will be announced after February 20, 2022. The specific methods and arrangements will be notified separately.

IV. Admission and Enrollment

Admission

The admission notice will be sent to the international students officially admitted as undergraduate students by post.

Review of the Identity of Enrolled New Students

According to the requirements of relevant documents of the Ministry of Education, CCOM will recheck the enrolled new students' identity after they enter the conservatory. Those who are not eligible for admission or have played favoritism and committed irregularities will have their academic status cancelled immediately once discovered.

Tuition Fees

According to the provision of China's Ministry of Education, the conservatory charges tuition fees. All the enrolled new students in 2022 must pay tuition. Approved by the price control department, the tuition is aimed to be 38000 Chinese Yuan/person/year for international students of all undergraduate majors in the conservatory.

Note: After the announcement of the Enrollment Guide, if the tuition standard of the conservatory was adjusted with approval from relevant competent department, the new standard tuition fees might be charged according to the new policy.

Instruments requirements after Enrollment

After being admitted, students must prepare all the instruments by themselves except piano, organ, percussion instruments (excluding snare drum) and harp.

V. Registration

- i. Government-supported students must register with the International Students' Office (Room 1529, New Apartment Building for International Students) and the Office of Academic Affairs on the specified date with the JW201 form, the admission notice, health check-up report, CSC materials and six half-length photos (3.5 X 4.5cm).
- ii. Self-financed students must register in the International Students' Office (Room 1529, New Apartment Building for International Students) and the Office of Academic Affairs on the specified date with the admission notice, health check-up report, and six half-length photos (3.5 X 4.5cm).
- iii. All the new students must go to Beijing Inspection and Quarantine Bureau for the health certification within a specified time after entering China with their own passports, "Physical Examination Record for Foreigner" and the reports of the blood test. Those holding unqualified "Physical Examination Record for Foreigner" or the reports of the blood test will be required to undergo a physical examination again. Those students who reject the physical examination or have the disease indicated by the examination result, thus disqualifying the entry as prescribed by the Chinese law, shall be ordered to leave China and return to their home countries.
- iv. In accordance with the provisions of the Ministry of Education of China, the international students who study in China for more than 6 months should purchase group comprehensive insurance in mainland China.
